Results-led briefing for clubs, events partners, and aligned capital. Underwrite from the live **layer3*** Results book — **path_a*** copy of locked **macd_hist*** / **macd_hist_inverse***, sit out when unlocked, with saved profit-take / stop / sizing rules. Full calendar month — only complete month in the measured Path A window.

Autonomous trading bots that work for you

Where we are headed

We built a trading house that works. The next chapter is a **shared-profit model** — desk / pool tickets, stakes that fund a shared **layer3*** book, and transparent give-back so clients participate in the harvest. A shared-profit model grows on its own; **pairing it with an existing company that already holds client trust accelerates that growth exponentially**. That is the partnership this memo is written for: proven Path A edge on our side, trusted clients on yours, shared upside for both.

The **\$100 club / desk seat with scheduled give-back** is the trust wedge. Members see the ledger; capital and share of profit come back on schedule. On-screen dashboards and transparent reporting exist for the same reason: trust first, then scale.

1 · **layer3*** Path A — the harvest foundation

layer3* is the one-account copy book above the RC sleeves. It does **not** invent entries — it copies the locked Path A sleeve and **sits out when unlocked**. The underwrite uses the production Results replay:

- **path_a* lock** — copy **macd_hist*** or **macd_hist_inverse*** when the day gap clears the lock threshold; sit out when the gap collapses.
 - PT / SL / healthy-balance rules from the saved Layer 3 config apply to the Path A book.
 - This memo underwrites the **measured Path A book** — the same series Results shows on the live desk.
- July 2026: **+\$21,305.50** · 2,365 fills · 58.5% WR · **+\$687.27 / day**. Knobs held while forward months accumulate.

2 · Why Path A (not every sleeve)

Partners underwrite **one coherent book**, not a buffet of bots. **path_a*** watches **macd_hist*** vs **macd_hist_inverse*** and only takes the locked sleeve. That is how the house stays selective, explainable, and sizeable — and why member dashboards can show a single Copy / Layer 3 narrative.

- **macd_hist*** / **macd_hist_inverse*** — competing sleeves; only the lock winner is copied.
- **layer3*** — Path A harvest book with PT/SL discipline.
- Unlocked = sit out. No forced trades to “look busy.”

3 · The opportunity

These markets are **secluded**. Most people do not know they exist; fewer still have a profitable operating house. This is not a pitch for a future prototype. **The **layer3*** Path A book is already measured end-to-end**. We don't require extra capital, but we would welcome it to demonstrate the system and grow client funds — weekly size-up and the rewards that hard work was always pointed at.

- **Live-validated stack** — RC sleeves + Path A vote lock + **layer3*** Results.
- **July 2026** — **+\$21,306** Path A PnL on the production book @ **~\$100** unit.
- **22/31 green days** — selective lock / sit-out, not flat every day.
- **Ready to size up** — same Path A rules, larger clips / multipliers.
- **\$100 seat = trust tool** — small yes, visible ledger, scheduled give-back; then grow seats.
- **Shared profit** — house → desks / syndicates & tickets; a trusted partner's clients accelerate growth.

4 · The systems we've built

Edge alone is not enough. Partners underwrite a **full stack**: operator dashboards, RC session control, **layer3*** Results / Live feeds, Path A gap monitoring, member Copies views, and automatic payouts after platform and partner fees. REST API for clubs and partner apps — tickets, members, payments, transparency.

5 · Position size — the multiplier we control next

Today's **layer3*** headlines were built at conservative ~\$100 units. That is deliberate: prove the edge, protect trust, earn the right to scale. **It is not the ceiling.**

6 · What the numbers imply

At \$100 unit size, a **layer3*** Path A book of **+\$21,306** in July 2026 is already in “fund the give-back seat” territory. Forward months turn this measured run into a longer ledger. Scale clips 5–10× with fill quality intact, and absolute harvest scales with them.

7 · Valuation bands
